Pledge of Allegiance/Call to Order

Mayor Greenwood led the Pledge of Allegiance and called the meeting to order.

Upon motion of Trustee Poellot, 2nd by Trustee Flaherty it was unanimous to approve the minutes for the November 4th, 2009 meeting.

Upon motion of Trustee Flaherty, 2^{nd} by Trustee Yonko, it was unanimous to accept the Treasurer's Report, subject to audit.

Public Comment

Bill Coffin had a broken waterline. It is now operational. Harold will check it for leaks and then disconnect the line.

General

Upon motion of Trustee Flaherty, 2nd by Trustee Poellot, it was unanimous that there shall be no registration day for the General Village Election to be held on March 16, 2010. In accordance with the attached full resolution.

Upon motion of Trustee Vernay, 2nd by Trustee Poellot, it was unanimous to accept the voter registration list of the Onondaga County Board of Elections as the official voter registration list to be used by the official inspectors of the March 16, 2010 Village Election. In accordance with the attached full resolution.

Upon motion of Trustee Poellot, 2nd by Trustee Vernay, it was unanimous to authorize the use of Town of Tully voting machines at the March 16, 2010 Village Election. In accordance with the attached full resolution.

Upon motion of Trustee Poellot, 2nd by Trustee Vernay, it was unanimous that the annual election shall be on the 16th day of March, 2010; that the Village constitutes one election district and the polling place for the district shall be the Municipal Building located at 5833 Meetinghouse Road, Tully NY; and the hours during which polls will be open shall be from noon to 9:00pm. In accordance with the attached full resolution.

DPW

Harold reported that the dump body is in the works. The Board approved the 12,000.00 truck body from Kurtz welding subject to warranty info.

Upon motion by Trustee Vernay, 2nd by Trustee Flaherty, it was unanimous to approve the replacement of the hydrant at the end of Sunny Drive. Bat-Con will do the work for 4,000.00.

It was approved for Harold to purchase the tires for the 08 Ford locally at a cheaper price.

Upon motion by Trustee Poellot, 2nd by Trustee Yonko, it was unanimous to approve the purchase of 40 tons of lime, at 1500.00, to get the farm ready for spring.

Counsel

Earley's have the opportunity to hook into the sewer line. The Village is waiting to hear from Mr. Earley regarding his intentions.

Upon motion by Trustee Flaherty, 2nd by Trustee Poellot, Counsel was given authority to prepare closing documents with M&T Bank for a 5-year, Statutory Installment Bond at 4.45% rate of interest and the Treasurer is authorized to execute such bond on behalf o the Village with respect to the new truck and tractor purchase by the DPW.

Tully Ag is not looking for a return of its second building permit fee.

There was a presentation by Napierala Consulting and Hueber- Breuer Construction about the new fire house.

Upon motion by Trustee Poellot, 2nd by Trustee Vernay, it was unanimous to waive the application fee for the new fire house.

Code Enforcement Officer and Counsel will conduct a preliminary review of the plans for the new fire house.

RESOLUTION VILLAGE OF TULLY December 2, 2009 Montrose Properties LLC Acceptance of Easements, Water & Sanitary Sewer Facilities

The following resolution was offered by Trustee Poellot, who moved its adoption, seconded by Trustee Flaherty, to wit:

WHEREAS, certain property owned by Montrose Properties, LLC (hereinafter, "Montrose") was duly annexed into the Village on February 13, 2008; and

WHEREAS, on the same date, the Village Board performed an environmental review in connection with said annexation; and

WHEREAS, in connection therewith, on the same date, the Village Board authorized and entered into an Agreement with Montrose related to the construction and installation of

improved water and sanitary sewer facilities to the Montrose property, including the requirement that Montrose post security in favor of the Village to guarantee performance of its obligations under said Agreement; and

WHEREAS, that Agreement was amended on March 4, 2009 to extend the period within which Montrose was obligated to perform until June 1, 2010; and

WHEREAS, Montrose has completed construction of the involved improvements and is prepared to convey said improvements by bill of sale, along with necessary easements in connection therewith to the Village; and

WHEREAS, the Village is prepared to conditionally approve and accept these improvements, bill of sale and easements.

NOW, therefore be it

RESOLVED, that this board, having reviewed the EAF submitted in connection with this request, hereby ratifies the Negative Declaration issued by this Board on February 13, 2008 and finds that there will be no adverse environmental impacts associated with the acceptance of these facilities and easements; and it is further

RESOLVED, that this negative declaration is based upon the following findings:

The system is being upgraded from a former extraterritorial use with respect to both water and sanitary sewer.

A 2006 capacity study prepared by Barton & Loguidice Engineers determined that there was adequate water and sewer capacity to serve the Montrose properties and uses and, in fact these properties are currently being served by the Village with both water and sanitary sewer service.

Construction of the improvements has already been accomplished and the action involves a conveyance of such improvements at no cost, to the Village.

As the Montrose property lies within the Village, the Village wishes to provide water and sanitary sewer service to the property owner; and it is further

RESOLVED, that the Village accepts the water and sanitary sewer facilities that have been constructed by Montrose, along with easements, the bill of sale and related documents subject to Village Counsel's approval and the Mayor is hereby authorized to sign any and all documents necessary to give full force and effect to this approval, subject to the following conditions:

The Agreement between the Village and Montrose, dated December 5, 2007, approved by the Village on February 13, 2008, as amended on March 4, 2009 shall be further amended to include a one-year warranty period for all infrastructure improvements being conveyed by Montrose to the Village, including any reclamation work.

The security required pursuant to the December 5, 2007 Agreement, approved by the Village on February 13, 2008 and as amended by the parties on March 4, 2009, shall be reduced from \$283,370.00 to \$50,000.00 for the duration of the warranty period, which shall expire one year from this date.

That said security shall warrant and guarantee the safe and good operation of the infrastructures constructed by Montrose and conveyed to the Village along with any consequent needed reclamation.

Subject to final sign off on the "punch list" items by the Village Engineer and DPW Superintendent.

Approval of the Final Subdivision Plan by the Village Planning Board.

Delivery to the Village of County Health Dept. approvals for both water and sanitary sewer improvements, for public use.

Village receipt of a final approval and sign-off from the NYSDOT with regard to highway work permits in connection with the Montrose water and sanitary sewer project.

The Village will not be accepting at this time a 40'+/- section of 8" sanitary sewer line, running off the manhole located on lot 8, near the current Kinney's Drug Store and intended to serve future development of the vacant lot 8

nor will it be accepting a 13' +/- section of 6" water line, at lot 8, from the 6" valve, which section is intended to afford future water service to lot 8.

Certification that all contractors have been paid in full and that there are no liens against the project.

Reimbursement to the Village of any and all fees incurred by the Village in connection with this project.
