Pledge of Allegiance/Call to Order

Mayor Greenwood led the Pledge of Allegiance and called the meeting to order.

DPW

Upon motion by Trustee Poellot, 2nd by Trustee Vernay, it was unanimous to approve the expenditure of \$550.00 from the General Fund for cabinets for DPW. All ayes carried.

The milk house at the Banner Farm is partially off the foundation. The DPW will take it down and clean up the rest in the spring.

The new tractor is in. The Board will hold on the purchase of a 2-way radio, at this time.

Counsel

In regards to the Tully Housing Company PILOT program, the Village will review the agreement and meet with the town to determine payments for years 2011-2034. The water and sewer department needs to make sure that the Housing Company is paying for assessments.

Counsel is still working on employee handbook.
