Back up generator: preliminary costs look like \$100,000.00. This will be added to the budget. Hot water heater: Harold received 3 quotes for a new water heater.

Upon motion by Trustee Poellot, 2nd by Trustee Yonko, it was unanimous to approve the quote placed by R. Shaw contingent on a standard contract guarantee. (\$3,554.00)

Aeration Tank: work has been completed and we are up and running

<u>Pumphouse Floor:</u> Work has been completed both floors have been sloped. There was no additional charge for the sloping of the Fluoride room floor.

Kurtz/Custer: Nothing further has been heard from Kurtz/Custer

<u>Tires/Wheels:</u> waiting for Spring and will probably sell the '08 tires Fire Extinguishers: awaiting pricing.

Upon motion by Trustee Yonko, 2nd by Trustee Coffin, it was unanimous to replace the front tires on the international truck for \$902.74. This includes dismount/mount and valve stems.
