WHEREAS, the Village of Tully Board recognizes that in order to achieve the above it needs to continue the existing a standard of quality and compliance for certain aspects and specific elements of the water system by which any future improvements must comply, therefore

BE IT RESOLVED, that for the purposes of establishing the standard of excellence mentioned herein, the Village of Tully Board hereby adopts the following standards for the specific water system components noted.

Water Meters – Sensus, Model iPERL with calibrations in 100 CF increments and utilizing the "Touchread" pad meter reading which matches the existing system.
