Mayor Flint-Morgan led the Pledge of Allegiance and called the meeting to order at 7:00pm. Motion was made by Trustee Oliver, 2nd by Mayor Flint-Morgan to approve the minutes for the June 6th, 2018 meeting. Ayes carried.

Upon motion by Trustee Poellot, 2nd by Trustee Oliver it was unanimous to accept the treasurer's report ending May 31st,2018, subject to audit.

Upon motion by Trustee Goodfellow, 2nd by Trustee Vernay it was unanimous to approve the transfers.

Upon motion by Trustee Oliver, 2nd by Trustee Poellot it was unanimous to accept the treasurer's report ending June 30th,2018 subject to audit.

Upon motion by Trustee Poellot, 2nd by Trustee Oliver it was unanimous to authorize the Mayor and the clerk to enroll in the NYCLASS (New York Cooperative Liquid Assets Securities System).

Upon motion by Trustee Goodfellow, 2nd by Trustee Vernay it was unanimous to authorize the Mayor to write a letter to David Hess confirming the Village request for LED street lighting for the initial cost of \$6,422.35, then a \$5,140.00 rebate, therefore the final cost to the village would be approximately \$1,200.00. The village would save about \$800.00 in lighting costs the first year.

declare National Grid as the sole source supplier for the WWTP interior LED lighting replacements.
