Upon motion by Trustee Poellot, 2nd by Trustee Bibik it was unanimous to approve change order 6A for \$8,969.16 for Scriba Electric. All ayes carried.

Ken Teter, Engineer received no bids for the Melinda Lane & Lagoon projects. We will reissue it again in the Fall in hopes that the response will be better.

Headlee Co., Inc. is the sole municipal market authorized representative and factory authorized service center for AUMA actuators, Inc. in NY for all counties north and west of but not including Westchester and Rockland counties. Letter from Auma may be viewed at the Village office during normal work hours. All ayes carried.
- Upon motion by Trustee Bibik, 2nd by Mayor Goodfellow it was unanimous to accept quote # RMHQ-30460 from R.M. Headlee for \$7,093.00 for the Auma actuator valve. All ayes carried.
- DPW Supervisor submitted a job description for the job posting for Village of Tully DPW. Counsel will send the board a sample to review.
- The tree on Warren Street has not been removed at this time. DPW has received no communication from the tree service.
